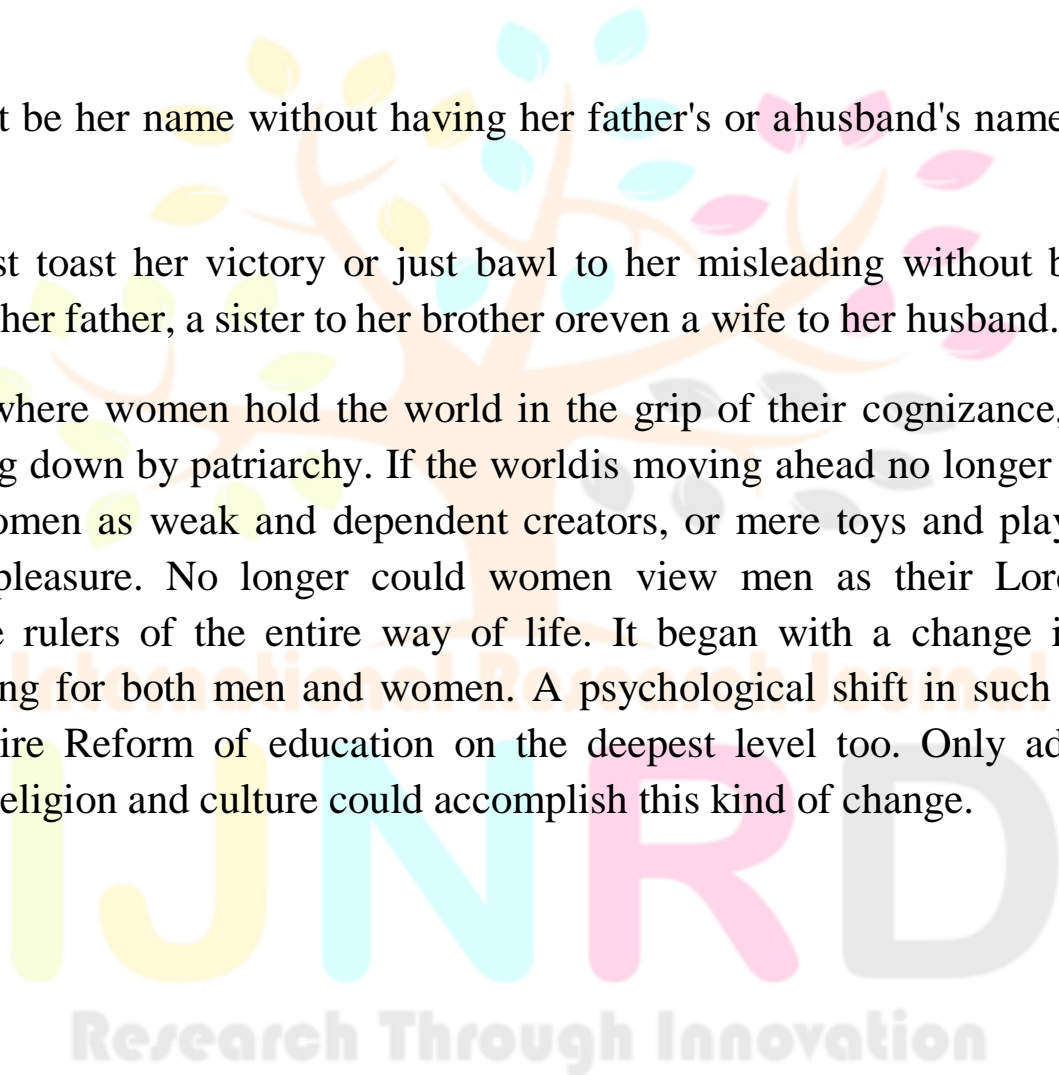
" The educated woman with power over herself, can bring down the patriarchy for the better betterment of all humanity" says Eileen Hunt Botting.

She brought education and religion together to advance a cultural revolution that would make women stand up and speak out, alongside men as moral equals deserving of the same Civil and political rights and bound by the same god given duty. Her core thesis was: " I do not wish women to have power over men; but over themselves".

Women will learn to say "NO" to things that she dislikes, she'll share the housework, problems and property equally, She will respect men but won't tolerate their wrong impositions on her, She'll talk about "periods", sex and sexuality openly, She'll be more of the bold types than the shy ones, she'll be the new trendsetter, she will be more of a feminist and not a sexist—the new generation of women in a real true sense.

As law holds our land, and is held "Supreme", the landmark judgement, Mary Roy VS State of Kerala still holds its significance. Mary Roy was a human rights activist and an educator. Ms Mary Roy was a widow and she claimed her equal rights under Article 14 of the Constitution for her father's cottage when she was harassed for the same by her brother.

She then sued her brother, George Issac in the lower court but the lower court denied her equal right to possession and hence,

she moved her appeal with the judgement of the lower court to the High Court of Kerala and claimed the violation of her Constitutional right to equality.

The court demonstrated that the law is supreme and the judgement was ruled in Ms Roy's favour as she stood by her right and fought for it for eighteen years. The Indian Constitution preserved Ms Mary's fundamental rights as she triumphed.

The main aspect of the system of patriarchy as an ideology is to create consent among women. Under this, women help to maintain the patriarchy, because through socialization she herself assimilates male domination and gives her consent to it. This consent of theirs is achieved in a number of ways – such as their lack of access to productive resources and their economic dependence on the head of the family. In this way, through different methods, women are made to get their consent in patriarchy. On this basis, it becomes necessary to understand that patriarchy is not just an ideological system but also has a physical basis.

Patriarchy deprives women of the means of power and domination, their consent is easily achieved and when women start living life on the behest of patriarchy, they start getting class facilities and are also awarded honor and respect, on the other hand, women who do not give their co-operation or consent to the laws and practices of patriarchy, they are labeled as evil and evicted from the property and facilities of their men.

According to Indian law, It is common in Rural areas, a marriage where either the woman is below the age of 18 or the man is below the age of 21. Again, being an age-old traditional practice, it's the rural parts that lead the race.

These rates were 3 times higher than the urban rates. In Mewat, a remote town in Rajasthan which lags behind in all socioeconomic factors, the percentage of married women who wed before they are 18 years of age is 16.9%. A big determinant of the age of marriage is education. Around 45% of women with no education and 40% with primary education married before the age of 18. However, different sources show a stark difference in the statistics, and allegedly, there is massive underreporting in India. People often resort to lies when it comes to telling the ages of their family members to avoid any legal ramifications.

Poverty coupled with the practice of dowry are the direct cause of the problem. And evidently, it all spirals back to patriarchy, as women are considered just a burden. People want to get rid of them, as they believe they will reap them nothing. They are scraped off their right to education, which is a big factor itself.

In all regions of the world, women are more likely to head single-parent families than men are. Time-diary studies in the USA indicate that even when fathers are single parents, they continue to do less childcare and work more hours than single mothers because single fathers more often share their residence with family members or other adults who can share domestic responsibilities.

There are more ways for women to be indispensable than just bearing children or managing the household. She can have the world in her eyes and the sway in her arms, her dreams have the height of an eagle and her strength is well commendable to achieve her aspiration, and this is my faith that every flower enjoys the air it breathes till its lungs are full with content and so women should have all her rights and her freedom to breathe in the courage that she is living in.
