Teachers, as professionals, are engaged in one of the ethically most demanding occupations which is education of a whole generation. The combination of knowledge, skill and competence makes a teacher effective in his/her subject or classroom situation but the integration of professional ethics can make a teacher an ideal one. Maintaining professional ethics can make a teacher a successful leader and motivator and in this process, the learners can also find a role model who inspires them throughout their lives.

In the contemporary world, degradation of professional ethics has created various problems in the educational institutions and also in the society and the teaching-learning process is most affected. The consequences are mirrored in teacher absenteeism, irregularities during examinations, lack of communication between teachers and learners etc. Teachers are not only professionals, they bear some moral roles and responsibilities which make them distinct from any other professionals. The present study seeks to explore the meaning of professional ethics, its role and importance in teacher education programmes specifically as reflected in NEP 2020.

# INTRODUCTION

Teachers, as professionals, are engaged in one of the most ethically demanding professions i.e. the education of the next

generation. Their behaviour and decisions, as an individual, may directly or indirectly impact the lives of many young people and the society at large. Therefore, it is imperative that teachers should constantly reflect on their activities and commitments to ensure that they exhibit the best ethical example possible. On the other hand, setting up such example on a daily basis requires a level of emotional engagement and commitment which only an ethical teacher can abide by. In order to make teachers ethically aware, the pre-service teacher education programmes should include the study of professional ethics in the curriculum.

This National Education Policy 2020 (NEP 2020) is the very first education policy of India in the 21st century and it emphasized on professional standards of teachers at all levels where professional ethics and values occupy an essential place.

## **REVIEW OF RELATED LITERATURE**

Teachers are the makers of all other professionals. Teachers have massive responsibilities as they are the inspiration, role models and motivators for thousands of learners both inside and outside the classroom (Green, 2010; Paschal, 2023). Teachers with profound knowledge on professional ethics have always enhanced the all-round development of the learners (Boon, 2011; Paschal, 2023). Professional ethics guide teachers to act ethically in demanding situations (Paschal, 2023). Professional ethics develop ethical awareness, accountability and compassion among the teachers (Paschal, 2023). Therefore, the teachers feel a sense of commitment towards their profession as well as the students. According to Rawat, Karkare & Yadav (2015), teachers always attempt to set up the best ethical example possible so that the learners can develop highest ethical standards. In fact, teachers are responsible and accountable to maintain the dignity and integrity of the profession (Rawat, Karkare & Yadav, 2015). Before entering in this ethically demanding profession, the aspirants should be well versed with the work ethics a teacher (Sherpa, 2018). Lack of professional ethics in teachers has resulted in various unfortunate events and raised ethical issues in the contemporary world (Paschal, 2023).

#### PROFESSIONAL ETHICS AND TEACHERS

Teachers, as professionals, are engaged in the process of making all other professions happen. Teachers have massive responsibilities as they are the inspiration, role models and motivators for thousands of students. In the school settings and even at the society level, teachers are highly trusted and considered to be role models in school and in the community (Paschal & Mkulu, 2020). From this notable standing point, teachers are the key element to ensure that learners are equipped with relevant skills, knowledge, values and attitudes. Professional ethics can strengthen student-teacher relationship. All the teachers are obliged to foster virtues such as integrity, persistence, responsibility, cooperation, loyalty, commitment and respect for everyone. Teachers should always stay away from conflict between their professional work and personal interests. The teachers should be impartial and must not discriminate any student on the basis of gender, race, caste, religion, language or any other criterion. The teachers must abide by the rules and regulations of the educational institutions and in this process the learners can also learn discipline and responsibility. Teachers should demonstrate respect for spiritual and cultural values, diversity, social justice, freedom, democracy and the environment. Teachers should uphold human dignity and promote equality. teachers should emphasize on integrity through their professional commitments, responsibilities and actions.

However, teaching as a profession goes beyond meeting these formal characteristics or criteria. It also includes emotions that are at the heart of teaching. The combination of the formal criteria & informal requirements, along with changing student learning needs has led to the evolution of teaching profession and the role of a teacher.

# WHY TEACHER EDUCATION IS CONCERNED?

Completion of teachers' training programme is compulsory for all the teachers engaged in school education whether in primary or elementary or secondary or higher secondary schools. Consequently, there is no denying of the fact that teacher education programme is an absolute pre-requisite for all the teachers. NEP 2020 recommended that the teachers must be grounded in Indian values, languages, knowledge, ethos and traditions including tribal traditions, while also being well-versed in the latest advances in education and pedagogy. And secondly, preparation of professionals must involve an education in the ethics, an education in the discipline,

## **RESULTS OF LACK OF PROFESSIONAL ETHICS**

**Teacher Absenteeism:** Teacher absenteeism is one of the most serious causes of ethical declining of education which greatly reduces the overall effectiveness of the institute, reduces students' achievements, damages the institute's reputation and induces student absenteeism.

**Biased Attitude towards Learners:** lack of professional ethics makes teachers biased or partial towards some learners while others are deprived from teachers' attention during classes.

Unfair Assessment: Lack of professional ethics can affect the assessment process as teachers sometimes grade the students based on their personal relationships, biased attitude etc.

Lack of Teacher-Student Relationship: Teacher-student relationship is one of the most sacred relationships which is based on love, respect and trust. Teachers who lack ethical behavior and commitments, cannot be trusted by the students. Thus, the teacher-student relationship cannot bloom.

Use of Abusive Languages: In some cases, it has also been found that teachers use abusive languages towards the students which is unethical.

# NEP 2020 ON TEACHER EDUCATION AND PROFESSIONAL ETHICS


NEP 2020 aims at producing engaged, productive and contributing citizens capable of rational thinking and action, possessing compassion and empathy, courage and resilience, scientific temper and creative imagination, with sound moral and ethical values. That is why NEP 2020 believes that the teacher must be at the centre of the fundamental reforms in the education system because they truly shape our next generation of citizens or the future of our country.

Teacher education is vital in creating a pool of schoolteachers that will shape the next generation. Teacher preparation is an activity that requires multidisciplinary perspectives and knowledge, formation of dispositions and values and development of practice under the best mentors. All teacher education programmes should also emphasize the practice of the Fundamental Duties (Article 51A) of the Indian Constitution along with other Constitutional provisions while teaching any subject or performing any activity.

Based on the recommendations of NEP 2020 on teacher education and training, a National Curriculum Framework for Teacher Education, (NCFTE 2022) is drafted to guide all teacher education, pre-service and in-

service programmes of teachers working in academic, vocational and special education streams. The policy envisages that the curriculum and pedagogy of the institutions must develop among the students a deep sense of respect towards the Fundamental Duties and Constitutional values and a conscious awareness of one's roles and responsibilities in a changing world.

As per the recommendations of NEP 2020, a common guiding set of National Professional Standards for Teachers (NPST) was to be developed by the National Council for Teacher Education (NCTE) by 2022. NPST ensures that all students at all levels of school education are taught by passionate, motivated, highly qualified, professionally trained and well-equipped teachers.

NPST has divided the teachers into four categories according to their performance criteria and has delimited their duties on different standards. Standard I which is core ethics and values has been divided into 2 domains of i. Constitutional values and ii. Professional ethics and values. Based on performance criteria, the teachers are divided into four categories of Beginner teacher, Proficient teacher, Expert teacher and Lead teacher. In the following table, we can see that the role of different level teachers has been explained lucidly about how they should behave and how they can inculcate professional ethics and values among the students.
