## MEDIA BIAS IN WESTERN PRESS

**Pro-Israeli Stance in Global and Western Media:** The global and Western media have long been criticized for adopting a pro-Israeli stance in their coverage of the Israel-Palestine conflict. This bias manifests in the language used by journalists and the framing of events, often portraying Israelis in a more sympathetic light compared to Palestinians.

**Glasgow Media Group Study Findings on Language Discrepancies:** A study conducted by the Glasgow Media Group highlighted significant discrepancies in the language used by Western media to describe Israeli and Palestinian actions. Terms such as "atrocious," "brutal murder," and "terrorist" are frequently associated with Palestinians, while Israeli actions are often portrayed in a less harsh manner.

**Euphemistic Language Usage to Minimize Severity of Israeli Actions:** In addition to language discrepancies, Western media outlets have been accused of employing euphemistic language to downplay the severity of Israeli actions. For example, the New York Times changing headlines regarding the Gaza hospital attack suggests a deliberate attempt to soften the portrayal of Israeli violence.

**Analysis of Headline Changes in Prominent Western Newspapers:** The alteration of headlines in prominent Western newspapers, such as the Washington Post and BBC News, further underscores the prevalence of bias in media coverage. These changes not only obscure the reality of Israeli aggression but also perpetuate a narrative that disproportionately favors Israel.

## **MEDIA BIAS IN TURKISH PRESS**

**Expression of Bias and Hatred in Turkish Media:** Similarly, the Turkish media has been criticized for its expression of bias and hatred in coverage of the Israel-Palestine conflict. Terms such as “Usurious Jew” and “Raid on perverted Greek” reflect a deeply ingrained prejudice that colors reporting on the region.

**Lack of Solution-Oriented Journalism and Resort to Propaganda:** Rather than engaging in solution-oriented journalism, Turkish media outlets often resort to propaganda tactics that exacerbate tensions and perpetuate division. This approach undermines the possibility of constructive dialogue and peaceful resolution.

**Religious and Cultural Influences on Media Coverage:** Religious and cultural influences further shape media coverage of the conflict in Turkey, with a preference for narratives that align with religious and national identities. This exacerbates polarization and impedes efforts to foster understanding and reconciliation.
