




HOW MANY OF THEM REALISE THAT THEY ARE SKILLED AND HAVE AN OBLIGATION TO FULFILL.

# **FINDINGS**

- 1. According to the data collected through the sample size it was found that 155 woman respondents are optimistic about their realization of obligation whereas 113 of them are extended upon implementing their skill.
- 2. The data also analyses the fact that 55 women respondents are neutral towards their obligations while 72 respondents have no intention of implementing their skills.
- 3. Furthermore 50 and 70 respondents were ignorant of their obligations and practical implementation of their skills.
- 4. It was also found that both realization and application of their skill were slightly positively correlated to each other.
- 5. Skill development and Innovative Strategy are perfectly correlated.
